All information is confidential to be used by Pupcakes Playcare with respect to your dog(s)

Pupcakes LLC (aka Pupcakes Playcare) Policies and Terms of Agreement:

- Pupcakes, LLC, reserves the right to immediate change or remove my dog's Playcare or Boarding situation if Pupcakes finds the need to protect my dog, other dogs, or our staff.
- Pupcakes Playcare is a cage/crate free environment. I understand that even with the most diligent supervision, there may be risk of injury while playing with the other dogs either in the garden area or in the indoor play area. Pupcakes Playcare provides supervision for all dogs in its care, but cannot guarantee the possibility of disease (either contagion or flea infestation) transmission, escape, or injury.
- I understand that all dogs are required to be picked up before close of business. Late fees may be instituted on a per minute basis for late pickups, or if boarding is available, my dog(s) will be boarded overnight at the current published rate, and may be picked up the following morning.
- I understand that a credit card number is required to secure boarding reservation for my dog(s). Cancellations less than 48 hours prior to my reservation, or failure to show up for my reservation, will result in a charge of one night's boarding.
- I confirm that my dog(s) is friendly and has never shown any aggression toward other dogs or people. If my dog causes any injuries, it is my responsible for all medical or veterinary bills that may incur.
- I accept full responsibility for payment of all medical bills incurred on my dog's behalf if Pupcakes determines that my dog requires medical attention. I release Pupcakes, LLC and its officers, agents, and employees from any and all responsibility for, or claims, debts, or damages related to such medical care.
- I understand that the liability of Pupcakes, LLC, in any circumstance related to my dog(s) shall not exceed the current chattel value of a dog of same or similar breed as the one in the care of Pupcakes, LLC.
- I agree to indemnify, release, and hold Pupcakes, LLC, harmless from any liabilities, claims, loss, suits or legal actions and expenses from any claim made, or caused to be made against Pupcakes, LLC, for which it, its agents or employees are not ultimately held to be legally responsible without limitation including, but not limited to, dog bites, dog attacks, transmission of diseases, damage to property, and breach of contract including any inaccuracy provided to Pupcakes, LLC.

I further understand that I have read, accepted, and understand the terms of the agreement.

I agree to update my information, or my dog(s) information as necessary in regard to contact information, medical information, and pick up contacts.

I understand the risks of a cage/crate free environment, and there is a possibility of injury, transmission of fleas, or communal illness and disease.
